The Randolph Fire District #1 (RFD1) Prudential Committee offers this newsletter to inform and update District members about activities and ongoing issues. Enclosed with this newsletter you will also see the Consumer Confidence Report (CCR) for 2021 which by federal regulation is issued annually by each public water system. The report indicates the results of chemical testing routinely performed to monitor water quality to be within State and Federal Drinking Water standards. You should feel free to contact us with questions or concerns about the report, and about your water quality or water pressure. ## **Management and Operations Update:**

Randolph Fire District #1Annual Meeting – The annual meeting was held on Tuesday, May 17, 2022, at the Red School House at 7PM. Meeting minutes are posted on the website. Note that we have an open position for the Prudential Committee clerk. We are grateful to Mary Shappell for her several years of dedicated service through the end of our fiscal year in May 2022. Please consider serving our community water system in that role.

We are closely monitoring the water level in our spring source after two consecutive months of less than half of normal rainfall. Our source level remains adequate, and we have VTC's source concurrently supplying water to our system, so we do not foresee water use restrictions in the short term (i.e., next month or so). We ask you to continue to be prudent with outside water use and will keep you informed, including advising if additional conservation measures are needed.

We continue to have opportunities for participating in your water system operations. We will gladly meet with you to explain what our system comprises and how it functions. You might find a role for your interests and talents to serve you community, or you may simply want to satisfy your curiosity (a family member's) about how your drinking water and fire protection get to you. There are many ways you can contribute to keep RFD1 an independent provider of clean and plentiful water.
